

Jan. 8, 2019 Program - Tiffany Runyan, Development Specialist with Love146 Human Rights Organization

Love146 Mission: Love146 is an international human rights organization working to end child trafficking and exploitation through survivor care, prevention education and movement mobilization. We serve children from our offices in Asia, the United Kingdom, and the United States.

Tiffany Runyan is the Love146 Development & Mobilization Specialist. Prior to joining Love146, Tiffany spent the majority of her career working in professional sports. Through her church in Arizona, Tiffany was exposed to the issue of child trafficking happening all around the world and has been passionately involved ever since as both a volunteer and now on staff at Love146.



Feb. 12, 2019 Program - Justice Ken Wise, 14th Court of Appeals

Justice Ken Wise was appointed to the 14th Court of Appeals by Governor Rick Perry in October 2013. Prior to his appointment, Justice Wise served as the Judge of the 334th Judicial District Court in Harris County and Judge of the 152nd Judicial District Court in Harris County. In 2011, the 59 District Judges in Harris County elected Justice Wise to lead them as Local Administrative Judge.

Justice Wise is very active in the service of the bar and the judiciary. He co-chaired a State Bar task force that conducted the first complete study of the Texas Court system since 1894. He is also an expert on the U.S. Constitution and will be speaking to us about its history from beginning to current day.
